Using the 2020 Policy Survey to Validate EAVS Data

The Election Administration and Voting Survey (EAVS) project consists of two surveys that are administered separately. The Policy Survey is completed at the state or territory level and provides information about the election laws and policies that will be in place for the November 2020 General Election. The EAVS collects data points at the jurisdiction level about voter registration, overseas voting, mail voting, in-person voting and polling operations, provisional ballots, total participation, and voting technology.

The Policy Survey provides important context to your state's EAVS data and will help data users better understand the EAVS data that you submit. In addition, this year the Election Assistance Commission (EAC) will use your Policy Survey data to create customized validations for your state's EAVS data collection templates. These validations will ensure your two data submissions align with each other, will reduce the response burden for states and jurisdictions, and will help your state submit more accurate EAVS data.

The following validations will be programmed into both the online and Excel data collection templates (stay tuned for a future EAVS newsletter that will give you a glimpse into what these two templates will look like and how they will differ).

<u>Reminder</u>: The Policy Survey is closing at the end of this month. Seven states and territories have completed their responses so far. As you can see from this newsletter, it is vital that the EAC has every state's response by September 30, so we can correctly program your data collection templates before we release them in early November.
